



# CV OF JONATHAN COPE

## ADJUDICATOR | ARBITRATOR | EXPERT DETERMINER | MEDIATOR

### Summary

Jonathan is an experienced dispute resolver and has been appointed in over 400 construction and engineering disputes as either adjudicator, arbitrator, expert determiner, conflict avoidance panel member or mediator. These disputes have concerned projects ranging in value up to £20bn, and have been in a variety of sectors including infrastructure, power generation (including renewable energy and nuclear), hospitality, healthcare, offices, education and residential. Jonathan is on a number of panels of dispute resolvers, and is also named as dispute resolver in a variety of significant contracts and framework agreements. He is also regularly agreed to act as dispute resolver by parties and their representatives. Jonathan is a CEDR accredited mediator.


Examples of recent experience acting as dispute resolver include:

- Adjudicator: £6m dispute between national energy infrastructure company and JV concerning the proper assessment of compensation events (NEC3 ECC Option C)
- Adjudicator: £7m multi-party dispute between office building owner, main contractor and sub-contractors arising out of alleged defects (JCT D&B contract)
- Adjudicator: £4m dispute between hospital trust and main contractor concerning entitlements to extension of time and loss and expense (JCT D&B contract)
- Arbitrator: £1m dispute between cladding and drylining subcontractor and main contractor concerning value of account, termination and alleged defects (Bespoke subcontract)
- Arbitrator: £1m dispute between subcontractor and main contractor concerning the lawfulness of a suspension and associated damages (Bespoke subcontract)
- Expert Determiner: £10m dispute between an investment company and developer concerning completion issues on the purchase of a 700 unit residential development (Bespoke agreement)
- Mediation: Dispute between a home owner, contractor and architect concerning the costs of rectifying alleged defects (RIBA domestic building contract)

Jonathan has undertaken expert witness work in adjudication, arbitration and litigation proceedings, including the provision of oral evidence both in court and arbitration. He has acted as a party appointed expert, a single joint expert and a tribunal's expert. Jonathan has recently acted as quantum expert to an arbitral tribunal on a circa £320m dispute in the Middle East.

Jonathan is a former Chair of the UK Society of Construction Law (2018-20) and is a member of the Society of Construction Arbitrators, ARBRIX, the Adjudication Society and the DRBF. Jonathan is also a former Chair of the RICS Dispute Resolution Professional Group (2011-13), and is the principal author of the current edition of the RICS Guidance Note, *Surveyors acting as adjudicators in the construction industry*.


Jonathan regularly gives lectures and presentations on construction law and dispute resolution topics, both in the UK and internationally, for organisations such as the Adjudication Society, ARBRIX, Chartered Institute of Arbitrators, IBC, International Cost Engineering Council, RICS, Technology and Construction Bar Association and the Society of Construction Law. He has also written extensively on legal and ADR topics, and has had articles published in RICS Journals and Building Magazine. He was also a regular contributor to the Thomson Reuters Practical Law construction blog from 2008 to 2023.
